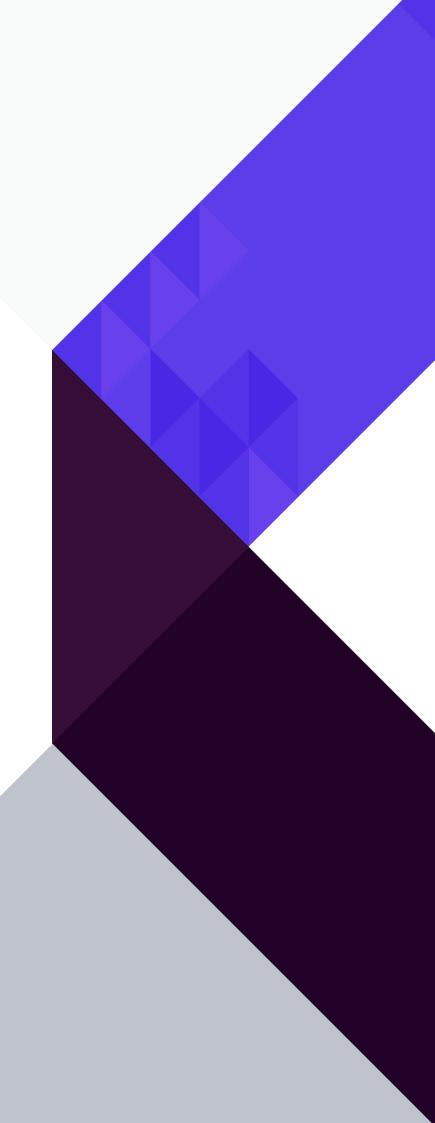

THE PHYSIOPEDIA 2019 - 2020

This is Physiopedia's second annual report and covers the period of June 1, 2019 through May 31, 2020.

It has been a busy year for Physiopedia, but thankfully we have continue to be supported by an amzing committed team. The team has grown to include a Content Manager, a Knowledge Translation Manager and a communications team, plus there are consistently around 70 people on the volunteer content editing team.

There are now 3,611 pages of content on the site and have been 261,599 edits to date. Currently around 1.8 million individuals, representing nearly every country in the world, use Physiopedia every month. Collectively they view between 4-5 million pages each month and spend an average of 2 minutes on each page they view.

In October we ran our annual open online course on traumatic brain injury. This year the course was funded by a private donation, that requested that we do what we can to share knowledge with therapists all over the world so that they are better equipped to manange individuals with traumatic brain injury.

Physiopedia continued to contribute to two collaborative projects this year, they are the Erasmus+ funded Physiotherapy and Refugee Education Project which aims to educate physiotherapists with skills to work with refugees, and the development of the World Health Organisation Rehabilitation Competencies Framework which aims to produce an internationally relevant competency framework for rehabilitation.

As a result of the COVID-19 pandemic we attended only one international meeting this year which was the Second Global Rehabilitation 2030 Meeting in Geneva. The meeting highlighted the increasing need for rehabilitation worldwide associated with changing health and demographic trends of increasing prevalence of non-communicable diseases and population ageing. As a result Physiopedia agreed to contribute to Rehabilitation 2030 by committing to educate rehabilitation professionals worldwide in all contexts and at all stages in their professional career.

Physiopedia very much continues to be a community driven project for the profession and is the most widely used physiotherapy resource in the world. It is a community gift to the global physiotherapy profession and and other health care professionals alike; everyone is invited to get involved.

Rachael qualified as a physiotherapist in 1998 with a first class degree from Sheffield Hallam University.

Before turning her attention to providing technology solutions for the physiotherapy profession, she successfully founded a private musculoskeletal physiotherapy service in the UK.

Now, in a voluntary capacity, Rachael oversees the day to day activities at the Physiopedia charity. She is also co-founder and CEO of Physioplus, Physiopedia's supporting online professional development platform.

In 2019 Physiopedia activity retained a similar trajectory, more volunteers, more edits, more projects, more quality evidence-based content, serving the global physiotherapy professions' thirst for knowledge. All that changed in early 2020 as the world watched the Coronavirus pandemic unfold.

The need for physiotherapists to understand how to respond to the pandemic and also how to assist individuals with COVID-19 was clear and the way that we at Physiopedia could assist became obvious. It is the first time that the Physiopedia team has dropped everything to make an immediate active response for a global need, and boy did they rally!

In 4 weeks the team produced content from the emerging evidence and created a series of online courses to assist physiotherapists manage the situation they found themselves in as a result of the pandemic. Whether it was managing their clinic or working with individuals infected with the disease, there was information available to them. Over 20,000 people in every country in the world utlised this educational opportunity within the first few months of the free courses being available.

The way that we, as a team, were able to make such a quick response and the reach that Physiopedia had in the early days of this emerging pandemic was a shock to us all. As a result, it has become evident that Physiopedia can make rapid and massive positive contributions to world events and this is an activity that will be integrated into strategic planning going forward.

I continue to feel privileged to be a part of this ongoing story and I am humbled by our team. They have a selfless motivation to do good in the world and Physiopedia is the vehicle that they are proud to do this by. This journey is by no means over, there is a long road ahead and much work to do to heal the world following this pandemic. The effects on mental health and wellbeing, and the role the physiotherpists have as part of the rehabilitation team continuse to emerge and the Physiopedia team will be there to do all that they can!

WHAT WE DO

Making meaningful impact on the global physiotherapy community

In order to satisfy its mission, Physiopedia focused on two main objectives in 2019/2020: to continue to provide a valued resource that freely shares quality physiotherapy knowledge globally; and to provide equitable access to educational opportunities for physiotherapists (and other interested health care professionals) all over the world.



Sharing physiotherapy knowledge

The Physiopedia website currently has over 3,600 pages of evidence based content and recieves around 5,000,000 page views from nearly every country in the world every month. Since it was founded, the site has received over 260,000 edits with a curent list of 174 active editors.



Free course on Traumatic Brain Injury

In November 2018, following a private donation that speicfically asked us to provide education for physiotherapists globally on this topic, we delivered a free online course on Traumatic Brain Injury. 20,522 individuals registered for this course from 185 countries making it the most popular Physiopedia MOOC to date.



The COVID-19 Response

With the generous support from World Physiotherapy, the Physiopedia team made a rapid response to create content for 4 free online courses to educate physiotherapists globally how to manage individuals with COVID-19. Following this initial response other content related to wellbeing during the pandemic and telehealth was also created. To date the content has had nearly 500,000 page views from every country in the world.

Humanity & Inclusion

Our partnership with Humanity & Inclusion continues to focus on providing online courses in French. This provides workforce training for their staff and partners working with vunerable populations, as well as opening up professional development opportunities to any french speaking physiotherapists worldwide.



Health Volunteers Overseas

With a common purpose to educate health care professionals, our partnership with likeminded Health Volunteers Overseas is a mutually beneficial collaboration where knowledge sharing and organisation support facilitates the advance of our combined efforts.

GLOBAL BROADCAST

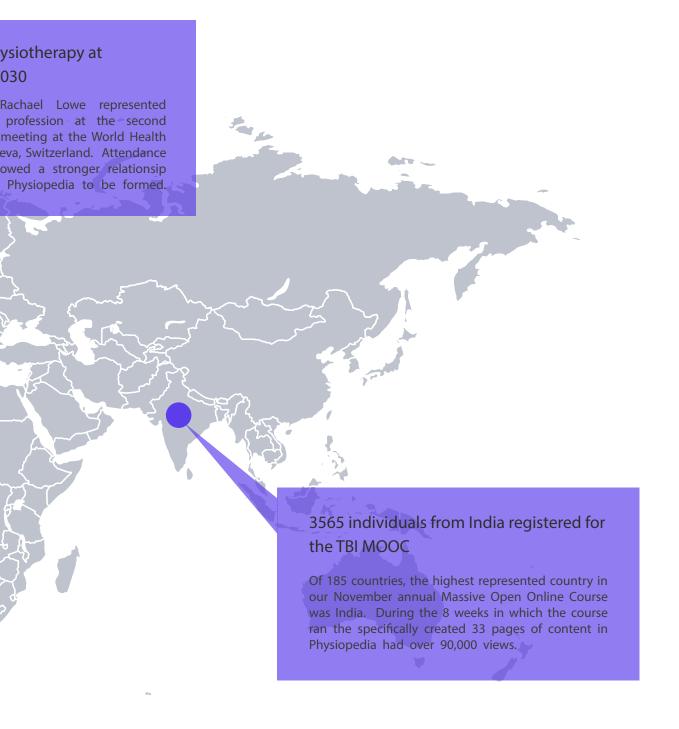
In the 2019/20 financial year between 1 June 2019 and 31 May 2020 Physiopedia received 25,843.643 page views by 14,815,039 indivial users from every country in the world.



Global Coronavirus Response

On March 16 Physiopedia in collaboration with Physiopedia Plus, launched the first Coronavirus course specifically aimed at physiotherapists. The programme of 4 short courses covered basic knowledge, infection prevention and control and physiotherapy management of COVID-19. In the first 8 weeks of the course being available there were over 350,000 views of the content that was specifically created on this topic by over 160,000 individuals from every country in the world. The course was made available for free through December 2020 thanks to the generous support of World Physiotherapy. This course was followed by 3 related wellbeing courses on sleep, nutrition and physical activity and a follow up series on rehabilitation is being planned.

Top ten visiting countries were: United States, United Kingdom, India, Australia, Canada, Philippines, Malaysia, Pakistan, South Africa and Ireland.



GOVERNANCE

Physiopedia is registered with the Charity Commission (registration number 1173185) and complies with the Charities Act 2011. The objects of the charity are, for the public benefit, to improve health globally by advancing education in relation to physiotherapy and improving access to physiotherapy knowledge.

Under UK law, the Physiopedia Charity is subject to section 396 of the Companies Act 2006 and operates as a company limited by guarantee and not having share capital (registration number 08530802). Physiopedia's constitution is set out in the Articles of Association which are filed at Companies House.

The Physiopedia Trustees have responsibility for the control and direction of the affairs of the charity. The Trustees are supported in their governance function by the Advisory Council. The Trustees and Advisory Council receive no remuneration for their duties.

General

Physiopedia is a charitable company limited by guarantee and is incorporated in United Kingdom (registration number 08530802). The registered office address is 10 Queen St Place, London, EC4R 1BE.

Public benefit entity

The charitable company meets the definition of a public benefit entity under FRS 102.

Going concern

The trustees consider that there are no material uncertainties about the charitable company's ability to continue as a going concern.

Personne

As at 31 May 2020, the Charity had no staff members employed. The Trustees receive no remuneration for their duties. Expenses can be reimbursed.

Related Parties

Rachael Lowe and Antony Lowe are directors and shareholders of Physiopedia Plus Ltd, which provides support services to Physiopedia free of charge. The cost of these services, where quantifiable, is included in the accounts both as costs and as a donation. The directors of Physiopedia Plus Ltd also devote a substantial part of their time to the activities of the charity entirely on a voluntary basis. The value of these services has not been quatified.
